**PUBLIC UTILITIES REGULATORY COMMISSION (PURC)
PUBLICATION OF POWER TARIFFS**

In accordance with statutory duty to publish by the Public Utilities Regulatory Commission under Section 19 of the Public Regulatory Commission Act, 1997 (Act 538) this publication made this 30th day of January, 1998.

1. The Volta River Authority (VRA) shall charge the rates provided for in the First Schedule hereto a Bulk Supply Tariff (BST) to take effect from 1st February, 1998 and 1st September, 1998, as stipulated in the said First Schedule respectively.

2. The Electricity Company, Ghana Limited (ECG) and Northern Electricity Department (NED), Volta River Authority (VRA), shall charge the rates provided for in the Second Schedule hereto as Distribution Service Charge (DSC) to take effect from 1st February, 1998 and 1st September, 1998 as stipulated in the said second Schedule respectively.

3. The Electricity Company, Ghana Limited (ECG) and Northern Electrification Department (NED), Volta River Authority (VRA), shall charge the detailed tariffs stipulated in the Third Schedule hereto as End-User-tariff to take effect from 1st February, 1998 and 1st September, 1998.

4. The Electricity Company, Ghana Limited (ECG) and Volta River Authority (VRA), shall charge the rates provided in the fourth schedule hereto as a surcharge for consumers, who consume above 70% of their current consumption to take effect from 1st February, 1998.

4. These approved rates shall not be exceeded and shall remain in force until they are changed by the Public Utilities regulatory Commission.
